Affinity Group Direct Action Legal Support Form

This form is for anyone going to protest where there may be arrests. It's a way to share the minimal amount of information to track you in jail if you get arrested. (And people get arrested without planning on it all the time.) You'll notice it does **NOT ask for your immigration status or if you have any outstanding warrants**. That info should only be shared with people with whom you share a very high degree of trust. *These documents will be destroyed when the protest is over and/or everyone in it is out of jail.*
